### 3.1 Thematic session: Risk and resilience factors in pain (Gerbrandszaal)

Vervoort	Development of responder criteria for multidisciplinary treatment in fibromyalgia.
Evermann	Cortical pain processing differences in chronic pain patients with and without personality disorders.
Taal	Longitudinal relations between changes in self-efficacy and positive adaptation in patients with polyarthritis.
Mathijssen	Rheumatoid arthritis patients' needs and preferences for support regarding their medication use.
Veldhuijzen	Autonomic nervous system functioning, subjective stress and interoceptive awareness in patients with fibromyalgia.

### 4.1 Thematic session: Stress & Burden (Nooterzaal)

Lobato	Is parental behavior associated with adolescent marijuana use and risky-use?
Rippe	Hair cortisol: potential confounders and how mild perinatal adversity moderates cortisol association with harsh parenting.
Bosch	Low socio-economic status and job stress amplify the effects of latent cytomegalovirus infection on T cell senescence.
Egberts	Parental presence or absence during wound care procedures after pediatric burn injury: a qualitative study.
Van der Donk	Type of depressive symptoms related to need for psychological care in depressed individuals with diabetes.

### 4.2 Symposium: Psychological factors influencing pain perception: an experimental approach (Gebrandszaal)
